Some changes introduced this year:-

- Suspending the £5000 minimum value requirement in the mid-tier to make it more accessible to smaller, upland farms in particular
- Changing the reduced inputs grassland options GS2 (lowlands) and GS5 (uplands) to make parcels adjacent to watercourses eligible
- Relaxing the soil testing requirements for GS2/5 so that they only need to measure levels of pH and phosphates
- Increasing the range of options available for upland farmers in mid-tier by allowing the lenient grazing (GS17), cattle grazing (SP6) and hay making (GS15) supplements to be used with low input grassland option GS5 in Severely Disadvantaged Areas (SDA)
- Making the livestock exclusion supplement to scrub management (WD9) available above the Moorland Line
- Making a range of adjustments to organic options to address the problems we've experienced with those in 2015
- Added CS targeting data to Magic Maps to help applicants achieve a successful application by identifying priority features and issues being targeted in their area - <http://magic.defra.gov.uk/MagicMap.aspx>
- Introducing an online options tool which will help applicants choose the most appropriate options in their area. This should be on Rural Payments alongside the revised and updated options guidance that you have helped us produce and incorporating the above changes.

Catchment Sensitive Farming Update

Countryside Stewardship Catchment Sensitive Farming can provide advice for farmers applying for the Mid Tier Countryside Stewardship scheme. Certain holdings within the Wye and Teme catchments are eligible for a visit by a CSF Officer to look at options available through the scheme to address water quality issues. Some items within the grant need approval from a CSFO before they can be applied for. Countryside Stewardship is available as five year agreement or a one year capital only Water Grant. To find out whether you are eligible please contact the relevant Catchment Sensitive Farming Officer on the details below.

Specialist Advice visits CSF also has a range of specialised advice visits available to farmers within the Wye and Teme catchments. These are free of charge and can provide you with detailed advice on a number of topics. Popular visits at present are the Farm Infrastructure Audit which provides advice on the farmyard and how this could be affecting water quality, as well as prioritising potential improvements that could be made. Also a Bio-bed and Pesticide design visit provides detailed advice on for farmers considering installing a Sprayer loading area with bio-bed or bio-filter. A number of other visits are also available such as Manure Management, Soil Husbandry and Water Management. If you are interested in any of these please get in touch with your local CSFO to discuss this.

The course will be specifically tailored towards those working with rural communities. This is especially pertinent as farmers and families are under huge amounts of stress at the moment. It can be daunting to approach someone who you are concerned about and this course offers some tools which will help you care for others, and care for yourself at the same time. Funding to support training in Herefordshire

We are pleased to announce the launch of two new initiatives that will provide funding to the rural community in the support of training.

Prince's Countryside Fund

The Herefordshire Federation of Young Farmers' Clubs (HFYFC) working in partnership with Herefordshire Rural Hub have been successful in securing a second round of funding from the Prince's Countryside Fund. This will provide support for training in a **rurally based career** over the next 3 years, to the end of December 2019. The funding is easy to access. All you need to do is select which course you would like to go on and complete the application form. You will be notified within 1 month if you have been successful or not. If your application is approved you will be able to reclaim **70%** of your training and test costs, up to a maximum of **£250**.

Applicants are required to be a member of HFYFC (aged 10yrs – 26yrs) or a past HFYFC member (27 – 40 yrs)

The fund will support training that will; **improve your employability, increase or improve your skill set, improve your safety or allow you to undertake extra responsibility in your current job.**

The Jack Hughes Fund

administered by Herefordshire Community Foundation

In 2015 the Herefordshire Community Foundation took on the management of funds that were originally raised by the Herefordshire Proficiency Test Committee (HPTC). This is being used to support a County-wide training fund that is named after the late Jack Hughes, who was the founder of Herefordshire PTC, and did so much work in ensuring that training skills were accessible and available to the farming community in Herefordshire and in particular for young farmers.

Having supported 50 Herefordshire farmers in 2015 with funding for the Award in the Safe Use of Pesticides Grandfather Rights training we are now launching a new programme which is designed to sit alongside the Prince's Countryside Funding (as explained above). This will be available for farmers **aged over 40 yrs** and will specifically provide funds to support those who require:

- retraining or upskilling as they are leaving the industry
- training to support a new farm diversification enterprise
- training or business support for succession planning

If your application is approved you will be able to reclaim **70%** of your training and test costs, up to a maximum of **£250**.

Pedlars and the law

It is a criminal offence to act as a pedlar without a certificate - or to fail to show it on demand to the householder or a police officer. If a "pedlar" turns up at your door and is unable to produce a pedlars licence to show you when trying to sell you something, please call the police on 101.

Police warning following distraction thefts

- West Mercia Police is continuing to urge people to be vigilant following a spate of distraction thefts, where offenders have observed victims' pin numbers being entered into cash machines or chip-and-pin machines, and then distracted victims in order to steal their bank cards.
- Please warn any friends or relatives to remain vigilant, and to look out for elderly shoppers when they are in supermarkets and car parks, as they are especially vulnerable to this crime.
- When in a shopping queue look out for 'shoulder surfing' by offenders attempting to view PIN numbers being entered.
- Shoppers are urged to be vigilant and to ensure PIN numbers are covered when using a checkout or cash point..

Be part of a Fighting Farm Crime Discussion

Kreseda Smith is a Doctoral Researcher at Harper Adams University in Shropshire, and is undertaking research addressing how the uptake of crime prevention measures can be improved on farms.
