Nuffield Farming Scholarships

Are you interested in becoming a Nuffield Farming Scholar and following in the footsteps of the many who have become scholars in Herefordshire and the surrounding counties?

Nuffield Farming Scholarships date back to 1947 when with the help and sponsorship of the Nuffield Foundation people involved in agriculture were able to receive financial help to travel world-wide to study a topic of their choice. Eventually the Nuffield Foundation withdrew from the supporting farming scholarships which led to the advent of the Nuffield Farming Scholarships Trust. The NFST took over both organising the scheme and raising money from the agricultural industry to fund the scholarships. The Three Counties Agricultural Society now sponsor a scholarship for those living or working within the area covered by the society.

What does a scholarship bring? It opens doors giving access to world leaders and decision makers, it gives global access to leading farmers and agricultural entrepreneurs, it gives an opportunity to look at research, new developments and to be able to come face to face with innovative advances in farming, forestry and the food industry.

Who can apply? Anyone between 25 and 45 years old who is engaged in farming, farm management and land management or involved with forestry and the food industry and please note an academic qualification is not a necessity.

Funding to support training in Herefordshire

The Prince's Countryside Fund

The Herefordshire Federation of Young Farmers' Clubs (HFYFC) working in partnership with Herefordshire Rural Hub have been successful in securing a second round of funding from the Prince's Countryside Fund. This will provide support for training in a **rurally based career** over the next 3 years, to the end of December 2019. The funding is easy to access. All you need to do is select which course you would like to go on and complete the application form. You will be notified within 1 month if you have been successful or not. If your application is approved you will be able to reclaim **70%** of your training and test costs, up to a maximum of **£250**.

Applicants are required to be a member of HFYFC (aged 10yrs – 26yrs) or a past HFYFC member (27 – 40 yrs)

The fund will support training that will; **improve your employability, increase or improve your skill set, improve your safety or allow you to undertake extra responsibility in your current job.**

The Jack Hughes Fund

administered by Herefordshire Community Foundation

In 2015 the Herefordshire Community Foundation took on the management of funds that were originally raised by the Herefordshire Proficiency Test Committee (HPTC). This is being used to support a County-wide training fund that is named after the late Jack Hughes, who was the founder of Herefordshire PTC, and did so much work in ensuring that training skills were accessible and available to the farming community in Herefordshire and in particular for young farmers.

Having supported 50 Herefordshire farmers in 2015 with funding for the Award in the Safe Use of Pesticides Grandfather Rights training we are now launching a new programme which is designed to sit alongside the Prince's Countryside Funding (as explained above). This will be available for farmers **aged over 40 yrs** and will specifically provide funds to support those who require:

- retraining or upskilling as they are leaving the industry
- training to support a new farm diversification enterprise
- training or business support for succession planning

If your application is approved you will be able to reclaim **70%** of your training and test costs, up to a maximum of **£250**.

Rogue Traders

Dealing with rogue traders

Rogue traders are opportunists who call on people's doors to rip them off. They make repairs that don't need doing and may talk people into buying products that they don't want. Be on your guard, watch out for them, you can keep your door closed to protect yourself from their scams, fraudulent activities and offers that are quite literally – too good to be true.

Who are they?

Rogue Traders usually cold call under the guise of being either salespeople or trades people who offer cut price home improvement services or other products. They are always charming and very believable. They can also be very difficult to get rid of if they get through your door even if you ask them to leave. Such traders will charge a small fortune for poor quality work, unnecessary repairs or cheap goods such as double glazing or energy efficiency products.

What tricks do they use?

They sometimes offer to tarmac your drive, work on your garden, repair your roof or clean your gutters for a low price. They may say that your house needs urgent repairs. They may say they are only in the area for a short time. They may say that they have done work for your neighbour. They may also offer you unbelievable discounts. They may then demand large amounts of cash, claiming that the job has turned out to be bigger than they thought. Some ask for cash up front and are never seen again. Others may insist on driving people to their bank to pressure them into withdrawing their savings. Whatever they say - don't believe them.

What should you do to prevent doorstep crime?

Remember the **Three Step Plan**. You have the right to keep your door closed and tell them to go away. If you are suspicious of a cold caller, you can report them to 101 and give a description of them and any vehicle you may have seen them use. If they are selling goods or services and don't leave or return after you've asked them to leave, they are breaking the law - and can be prosecuted for ignoring your request.

Top tips

- Install an intercom or spy hole for extra security.
- Never agree to have work done or part with money on your doorstep.
- Always get written quotes from at least two traders for any work.
- You have 14 days to cancel any purchase of goods or services over £42 that you make in your home.
- If you agree a contract for goods or services in your house, you must be given the following information in a durable medium, otherwise a criminal offence may have been committed:
 - The conditions, time limits & procedure for exercising the right to cancel
 - the cost of returning the goods
 - if you request the contract to start within the cancellation period, the trader must inform you of any reasonable costs to be paid up until the time of cancellation.
- Always agree the price, payment arrangements and start/finish dates in writing before any work starts on your home.
- You don't have to pay in full until you're completely satisfied with the work and you could consider using stage payments throughout the work.
- Keep your home and belongings safe during works.
